### Sub. :- Provisional permission to start R.A.N.M. Course

The Maharashtra Nursing Council (MNC) examined the documents submitted by Shri Shivaji Shikshan Prasarak Mandal, Barshi's, College of Nursing, Solapur for permission to start R.A.N.M. Course. Maharashtra Nursing Council conducted inspection of the institution by a team of inspectors appointed by the Council on 23/01/2006.

The Council in its General Body Meeting held on 21/7/2006 resolved on the basis of the inspection report that the said institution is permitted as a special case to start R.A.N.M. Course for the academic year 2006-2007 with an intake capacity of 20 (Twenty) students subject to fulfillment of the following conditions

- 1 **Submit Essentiality Certificate from Govt. of Maharashtra & Suitability Certificate from Indian Nursing Council, New Delhi before admitting of next batch.**
- 2 **Trained nurses should be appointed in parent hospital in next two years without fail else the training of ANM will not be allowed to be continued.**
- 3 **Hostel should be well furnished, painting & mess facility should be made available.**
- 4 **Text books & reference books should be added in marathi languages.**
- 5 **Send the enrolled candidates list by 7th Sept., 2006 without fail.**
- 6 **Do not admit underage & overage students.**
- 7 **Male Candidates admission should be restricted to 10%**
- 8 **Always maintain the laid down norms as there may be an surprise inspection during the academic year.**
- 9 **Next inspection will be conducted after one year i.e. before the admission of next batch. Inspection fees of Rs.15000/- should be sent before 30th Oct., 2006.**

Comply the above deficiencies & then only admit the batch.
